

**MINUTES OF A REGULAR MEETING OF
THE BOARD OF DIRECTORS OF
SAN GABRIEL COUNTY WATER DISTRICT
HELD ON APRIL 14, 2026**

- CALL TO ORDER** A regular meeting of the Board of Directors of the San Gabriel County Water District was called to order on Tuesday, April 14th, 2026, at 8366 Grand Avenue, Rosemead, California at the hour of 4:00 p.m.
- ROLL CALL** Present at the meeting were Finance and Administration Manager Carmen Corona, Assistant General Manager Casey Feilen, Superintendent Carlos Cordona, Directors Taylor, Mamdapurkar, DeLaTorre, Saucedo and Vera and District Counsel Koczanowicz. Mr. Prior was absent.
- AGENDA** Upon motion by Director Vera, seconded by Director Taylor, the Board voted unanimously to adopt the agenda as presented.
- PUBLIC COMMENT** None
- MINUTES** Upon motion by Director Mamdapurkar, seconded by Director Taylor the Board voted to approve the minutes for the March 24th, 2026 regular meeting. Motion passed 5-0.
- DEMANDS** Director Saucedo motioned to authorize payments from the General Account in the amount of \$1,810,594.65 (chk#24317 - 24371) and an Electronic Funds Transfer from the General to the Revolving Account in the amount of \$174,114.68 (chk#14777 - 14824) including voided check# 14497. The motion was seconded by Director Mamdapurkar. Director Taylor asked about various checks for expenses related to water lube and rehab and Civiltech work on Well 16, Fwy undercrossing, Nitrate analyzer and Water Treatment Plant tanks and labor. Director Saucedo inquired about couple of developer job expenses. All questions were answered by staff to Board's satisfaction. Motion passed on a 5-0 vote.
- DISTRICT COUNSEL REPORT** District Counsel briefly told the Board about an upcoming Temporary Restraining Order hearing to prevent closure of a smoke shop that was selling illegal substances to the public.
- ACTION ITEMS** None
- MISC INFORMATION** Board received and filed the water well report. Director Taylor noted that Well 16 was off-line and that the Key well was a bit down. He stated that the rest of the report looked good.
- GENERAL MANAGER COMMENTS** Mr. Feilen reported that the Treatment Plant project is progressing well, just waiting for the electrical panels; that the office expansion project was approved by the City of Rosemead with conditions, which will be reviewed

by the General Counsel and that Well 12 repairs are awaiting the delivery of materials. He also advised the Board that the main line project on Live Oak was completed and that the Fwy undercrossing project is reaching some important milestones. May 11th the pits will be dug, May 14th track monitoring will be in place and May 18th boring will begin.
